Tax on Christmas 2024

Introduction

Christmas is a time for enjoyment with friends and family. Yet the holiday season is often also accompanied by additional pressure on household finances, as individuals plan to spend more than £650 on gift giving and making merry this Christmas. With the overall tax burden set to rise to record levels,¹ a significant proportion of this sum will be paid in taxes. Though it is the season of giving, the government is set to take even more from the nation's households compared to most months. Using information collected by Nationwide,² this note examines how much tax an average person will pay on their spending at Christmas.

Key findings

- A two person household will pay £184 in taxes on their Christmas spending, equivalent to the cost of six turkeys from Tesco enough for 75 servings.³
- This includes the £92 an average person will pay in tax on Christmas expenditures comprising:
 - £42 in VAT on presents
 - £18 in VAT on entertainment
 - £32 in VAT and alcohol duty on alcohol
- If they travel by car to visit friends and family over the holiday period, households will pay an additional £11 in VAT and fuel duty, bringing the total to £195.
- If their festive plans also include a flight abroad to a nearby European destination, they will pay an additional £13 in air passenger duty per person, bringing the total to £221.
- In total, it is estimated that the government will collect £5.3 billion in taxes on Christmas related spending and activities this year, slightly over half what is needed to pay for the £9.4 billion public sector pay rise announced earlier this year.⁴

Breakdown of spending

This note relies on research by Nationwide, which found that the average individual plans to spend £694 this Christmas, broken down into various categories as presented in the table below.

Presents and entertainment

Most goods and services are liable for the standard 20 per cent rate of VAT, with the exception of items such as books and children's clothes which are zero rated, 6 as well as some other items that are liable for a reduced rate. VAT is the main tax that will be incurred by expenditure on presents and entertainment. The tax on these categories has been calculated at the 20 per cent standard rate, amounting to £42.33 in VAT on presents and £18 in VAT on entertainment.

Alcohol

In addition to being liable for VAT, expenditure on alcohol is also subject to alcohol duty. Wine and beer duty in the UK are the third and second highest respectively compared to European Union (EU) member states, according to previous research by the TPA. 20,21 On average individuals in the UK drink around 3.4 pints of beer for every bottle of wine. 22 The average expenditure on alcohol over the Christmas period (£90) is equivalent to around four bottles of wine and 13 pints of beer. 23 With VAT and alcohol duty at £3.66 for an average bottle of wine and £1.40 for an average pint of draught lager, the total tax on alcohol amounts to £31.41.

Food

While most foodstuff is zero rated for VAT, many popular snacks and non-alcoholic beverages are not. Some non-alcoholic beverages are also liable for the soft drinks industry levy, also known as the "sugar tax" depending on their sugar content. This is 18p per litre for drinks that have a sugar content of 5-8g per 100ml and 24p per litre for drinks that have a sugar content of 8g or more per 100ml.²⁴ Without a more detailed breakdown of the average Christmas expenditure on food, it is not possible to calculate exactly how much of this will be paid in tax. As such, even though spending on food will incur at least some VAT and sugar tax it has been excluded from this analysis. This means the overall figure presented in this paper will likely be an undercount of the total amount of tax incurred on Christmas spending.

Travel

Travel by trains, boats, coaches and planes that carry ten or more passengers is zero rated for VAT.²⁷ Those travelling by plane, however, must still pay air passenger duty. This varies based on destination and class of travel. An economy class flight to somewhere in the EU like Spain would incur £13 in air passenger duty, while an economy flight to a further destination like New Zealand would be taxed £92.²⁸

If the £105 in average planned travel expenditure includes a flight to a nearby European destination, this will incur £13 per person in air passenger duty. With the Association of British Travel Agents estimating in 2022 that five million individuals planned to travel overseas over the Christmas and new year period,²⁹ the government could collect up to £65 million in air passenger duty.

Individuals also travel by car over the holiday season. Research by Kwik Fit, an automotive servicing and repair company, in 2023 found that seven in ten intended to make at least one car journey, driving on average 169 miles over 3.2 trips to visit friends and family.³⁰ The cost of travelling by car includes fuel duty which is currently 52.95p a litre on both petrol and diesel, the ninth highest and highest respectively compared with EU member states, 31 as well as VAT. Together these make up more than half the list price of both fuels. If they travel by car, households will pay £10.85 in VAT and fuel duty.

Assuming that seven in ten of the 28.4 million households in the UK travel by car over the 2024 festive period, 37 the government will collect £215.4 million in VAT and fuel duty from these journeys.

Total taxes collected

Adding together the taxes in all the above categories (excluding travel), results in a total of £92 per person. The latest population estimates for mid-2023 show an adult population of 54.2 million.³⁸ This means that the government can expect to collect around £5 billion in taxes on Christmas spending in 2024. With an additional £215.4 million in taxes on households' car journeys and £65 million in air passenger duty, the total Christmas tax bill stands at £5.3 billion.
